

## 2019 Prairie Art Exhibit and Auction Call for Entry

Symphony in the Flint Hills, Inc. (SFH) announces its Call for Entry annual juried Prairie Art Exhibit and Auction.

Kate Van Steenhuyse and Kristin Beal, co-founders of Harvester Arts in Wichita, Kansas, will be the 2019 Prairie Art jurors.

As we embrace our Ad Astra theme for 2019, we're turning our gaze toward the stars in search of answers to some probing questions. In 1000 years, there will be a new north star. How will we celebrate it? Will we be able to preserve the night sky long enough to see it? What role will the Flint Hills, recognized for its wide-open spaces and expansive night skies, play in the celebration? We're working with an all-star team of artists, scientists, and communities on a project that will culminate in our 2019 Signature Event in Chase County.

Artwork Requirements: Artists are eligible to submit up two (2) entries each. Submitted two-dimensional paintings, drawings, watercolor, or mixed media, shall thematically or graphically reference the Flint Hills of Kansas. Painting canvas should not exceed 36 inches or a total of 1,296 square inches. Paintings shall be framed or gallery-wrapped canvas with fully painted edges. Strap hangers with screws must be used to secure the wire hangers (no sawtooths, clip frames or string hangers permitted, please). Artwork must be current, created within the past two years.

A high-definition <u>digital file</u> of the original artwork, <u>entry form</u> and <u>waiver</u> must be submitted by <u>February 18.</u> Remember, this is the file from which your entry will be judged. Artists will be contacted via email by <u>March 12</u> if their artwork has been accepted. Completed juried work needs to be delivered to the SFH Gallery at 331 Broadway, by <u>April 19</u>. Open House for the juried works will be May 4.

<u>Pricing</u>: All artwork selected for the event will be eligible for auction. Artists are requested to set a <u>beginning bid price</u>; this will be the starting price for the Silent Auction. The artists will receive half (50%) of the total auctioned price, if sold.

<u>Right to Reproduce Image for Purpose or Promotion, Resale and Publicity:</u> SFH reserves the right to reproduce images for the purpose of publicity and promotion in the form of posters, prints, greeting cards, informational handouts, etc. One piece of artwork will be selected for the official SFH 2019 Limited Edition Commemorative Print. By submitting artwork to this exhibition, each artist agrees to this statement.

<u>SFH Signature Event Tickets:</u> Each artist with selected entry/s is offered a free general admission ticket if attending. We strongly encourage artists to engage the public in the art tent the day of the event. The Art Tent opens at 12:00 p.m. with Silent Auction ending at 8:00 p.m. Additional tickets may be purchase either through Eventbrite.com

<u>Liability and Responsibilities</u>: Artists retains liability for accepted artwork. SFH assumes no liability for the artwork submitted whether in transit or during its housing. By submitting artwork to this event, each artist agrees to this statement.

<u>Artist Statement:</u> Once being accepted through the jury process, artist will submit a short statement describing their work. This statement will be shown with their displayed work.
